Provenance:

The Sidney Historical Society Oral History Project Collection was donated to the Champaign County Historical Archives in September 2011.

Access:

The records are accessible to the public within applicable copyright restrictions and limited to use at the Champaign County Historical Archives of The Urbana Free Library.

Historical Note:

The Sidney Historical Society was formed in May 1987. Its purpose was to collect and preserve information regarding the history of Sidney, Illinois and its environs. One of its projects was to create and collect oral histories. From 1987 to 1989, Kevin Erb interviewed Sidney's older residents and then made the interviews accessible to members at the Sidney Public Library. The project also recorded lectures, discussions, and panels that were part of the monthly meetings of the Sidney Historical Society. The Sidney Historical Society was active until 1992. In 2010, a Dissolution of Domestic Corporation Not-for-Profit was issued and the Society was officially disbanded.

Scope and Content Note:

This collection consists of 30 audiocassette recordings that were created and maintained by the Sidney Historical Society. The audiocassettes consists of recordings of events that took place during the meetings of the Sidney Historical Society and interviews of long-time senior residents of Sidney. General information about these recordings can be found in the administrative and meeting records of the Sidney Historical Society (Collection 68). The donation included an inventory of 33 cassettes, however only 30 were donated. The three audiocassettes not included in the donation are "9/28/89 Quilt", "Dora Green Tape 1 5/2/87" and "Dora Green Tape 2 9/26/87".

Arrangement:

The 30 audiocassettes are arranged into two series: Sidney Historical Society Roundtable Discussions and Lectures and Sidney Residents Interviews. All audiocassettes are in chronological order within each group and are noted at the item level. The dates on the tape labels of the first series correspond with meeting minutes [See Collection 68]. Audiocassettes with unknown dates are at the end of each series.
