#### **Biographical Note:**

Thomson Rhodes Webber was born in Shelby County, Kentucky on October 6, 1807. He married Martha Thompson in 1831 and together they had three children: Joseph T., William Bowes, and Susan Ann Webber. In 1833 Thomson and his family moved to Illinois and settled in what is now Champaign County. In 1837, his wife Martha passed away and in 1838 he married Anna B. Carson, with whom he had two children: Robert A. and James H. Webber. Thomson was the first postmaster of Urbana and upon the organization of Champaign County he was elected Clerk of the County and Circuit Courts. He served as County Clerk for 25 years and Circuit Clerk for 28 years in addition to serving as Master in Chancery for the Circuit Court for 40 years. He died at age 75 in Urbana on December 14, 1881.

William Bowes Webber was born on October 31, 1836 in Urbana, Illinois to Thompson Rhodes and Martha Webber. In 1864 he married Sarah D. Barnett of Shelby County, Kentucky and together they had seven children, including Grace, Pearl, and William Barnett Webber. William Bowes studied law in the office of Judge William D. Somers and Captain John C. Moses. He was admitted to the bar 1863 and throughout his career he practiced with lawyers such as Judge Somers and J.O. Cunningham. In addition to a successful career as a lawyer in Urbana, William was also elected to the Illinois legislature in 1884 and elected Mayor of Urbana in 1893. He died in Champaign County on September 8, 1916.
