Historical Note:

Everett Melvin Knowlton was born May 5, 1852 in Windham County, Vermont. In 1877, Knowlton moved to Urbana and began working for E.H. Cushman & Co., druggists, at 135 West Main Street. He purchased this business in 1885 and two years later, in 1887, entered a business partnership with George M. Bennett, establishing the Knowlton and Bennett Drug Store. Bennett was born September 1, 1868 in Urbana and married Emma C. Yanos in 1890. Also in 1890, Knowlton married Hattie Bennett, George M. Bennett's sister, and they had two children; Miriam and Beth.

After Knowlton passed away in 1920, Bennett continued to run the business along with Knowlton's daughter, Miriam Knowlton Corrie, and son-in-law, Lester Linn Corrie. In 1925, Bennett remodeled the building with the help of his brother, John B. Bennett, as the builder, and Royer, Danely & Smith as architects. The renovated building reopened on December 15, 1926, and continued to serve as a drug store. After Bennett's death in 1935, the Corrie family continued to run the Knowlton and Bennett Drug Store until its closure in 1971.

Scope and Content Note:

This collection contains financial records, building plans, contracts, almanacs, and ephemera from the Knowlton and Bennett Drug Store at 135 W Main St in Urbana. The records date from 1913 to 1940. Many of the records relate to the 1925-1926 renovation of the Knowlton and Bennett Building.
