The Housing Authority of Champaign County Records were donated to the Champaign County Historical Archives.

Access:

The records are accessible to the public within applicable copyright restrictions and limited to use at the Champaign County Historical Archives of The Urbana Free Library.

Historical Note:

The Housing Authority of Champaign County was founded in 1939, two years after the U.S. Housing Act was passed. Originally, they managed traditional public housing properties. Burch Village in Champaign and Lakeside Terrace in Urbana were completed by 1953. In the 1990s, they began redevelopment to create mixed-income housing. Burch Village was demolished in 2005 and later replaced with Douglass Square, a mixed-income community. Lakeside Terrace was demolished for redevelopment in early 2006 using funding from HOPE VI, a program run by the United States Department of Housing and Urban Development.

Scope and Content Note:

The records contain agency annual reports, memorandums, and five-year and annual plans, as well as project and development plans and applications.

Arrangement:

The records are arranged alphabetically at the folder level.
