Historical Note:

Timothy O. Smith grew up in Urbana and was a practicing lawyer in Danville, Illinois, for many years until he retired in 2010. He became interested in Joseph Gurney "Uncle Joe" Cannon, a famous Danville resident and lawyer. The manuscripts contained within the collection are the result of many years of his research and writing.

Cannon was a protégé of Abraham Lincoln and served as state's attorney in the 27th Illinois Judicial Circuit, which included Champaign County, from 1861-1868. He lived in Tuscola, Illinois, for many years, and relocated to Danville, Illinois, in 1876. Cannon was elected to the U.S. House of Representatives and served 43 years (1873-1891, 1893-1913, 1915-1923). He held the post of Speaker of the House from 1903-1911.

Scope and Content Note:

The collection offers six separate manuscripts about Joe Cannon's family history, early life, and career. They include his family background starting around 1805 in Guilford County, North Carolina, and continuing to Parke County, Indiana, around 1840. Cannon's career includes time in Parke County, Indiana, law school in Cincinnati, Ohio, and his legal and political career in Champaign and Douglas counties.
