Biographical Note:

Marian Alma Ray Dunlap (August 28, 1919 – October 3, 2017) was born in Champaign County, Illinois, to John Wesley and Lennie Belle (Humphreys) Ray. She graduated from Champaign Central High School (1937) and married Robert Andrew Dunlap on April 16, 1942.

The couple moved to Effingham County, Illinois, where they owned Dunlap Implement Company from 1952-1977. They were also heavily involved in the Effingham County Fair, where Robert Dunlap served as director and president. Marian was a charter member of the Effingham County Genealogical Society, where she researched the Pace, Ray, Havice, and Dunlap families.

She died at 98 and is buried in Woodlawn Cemetery in Effingham County, Illinois.

Scope and Content Note:

This collection contains Dunlap's genealogical research on her family lineage, including the Lawrence, Thomas, Humphreys, Butcher, and Watkins families. The files include family group sheets, supporting documentation, and family narratives for the descendants of:

- Philip Lawrence, Sr. (1727-1799) and Susannah Funkhouser (1738-1802)
- William Thomas (1765-1828) and Catherine Lawrence (about 1773-)
- James Humphreys, Sr. (1750-1831)
- William M. Butcher (1778-1850) and Christena Hildebrand (d. pre-1850)
