Provenance: Items in this collection were donated by Robert K. McCandless in January 2012.

Access: The records are accessible to the public within applicable copyright restrictions and limited to use at the Champaign County Historical Archives of The Urbana Free Library.

Biographical/Historical Note: Robert K. McCandless was owner and photographer of McCandless Photography, a studio in Urbana and Champaign, Illinois, specializing in portraits including school, baby, family, and wedding portraits. Born in Hershey, Pennsylvania, McCandless worked at the Evening Standard in Uniontown, Pennsylvania and in the Air Force from 1951-1953 (in Korea from 1952-1953) as a public information officer. He was a district chairman and later national chairman for the Freedom of Information Committee of National Press Photographers Association. In April 1956 he joined the *Urbana Courier* as a photographer. In 1965 he left the *Courier* and opened McCandless Photography at Washington and Race Streets in Urbana. He moved the studio to 113 W. University Avenue in Champaign in 1974-1975, and moved to Lincoln Square Mall in 1983. He closed the studio in 2011. He served as a member of the Urbana Free Library Board of Trustees and an active member of the First Methodist Church in Champaign.

Scope and Content Note: The collection consists largely of studio and outdoor portraits of residents of Urbana, Champaign, and nearby towns. Dates range from January 1965 to March 2011. McCandless photographed groups such as the Urbana Police, Urbana Firemen, Champaign County Bar Association, and the First Christian Church for directories, as well as other organizations such as Boy Scouts and fraternities and sororities. The collection consists largely of negatives (probably acetate) and prints in envelopes. A typical envelope might include an order form or receipt, mask with negative, other negatives (sometimes in plastic covering), and one or more printed proofs. There are both color and black and white negatives and proofs. Each envelope typically has identifying information written or typed on the envelope including customer name, date, address, phone number, and customer number. There are 14

boxes containing index cards which provide cross reference to the negative envelopes in some series. There are 2.5 boxes of CDs, each CD contains approximately 1-10 TIFF or JPEG files. Files range in date from January 2007 to March 2011. After the studio closed and before transfer to the archives, McCandless sold some but not many of the negative envelopes to the subjects.

Arrangement: Arrangement follows McCandless' order, and series are reflective of different project types as well as his method of organization (in some series, cards provide an alphabetical cross reference through customer numbers to negative envelopes). When envelopes are arranged by customer number, note that customer numbers typically—but not always—correspond to a chronological order of arrangement. It appears that customer numbers correspond to customers, though in some cases it appears that numbers correspond to the sitting.

Series 1

Early White (01/1965-12/1976). Photographs taken in the early years of McCandless' studio career. Envelopes are arranged by customer number; index cards are arranged alphabetically by customer's last name and can be cross referenced to the envelopes through their order numbers. The cards are physically separate from boxes containing envelopes. This series includes portraits of individuals of the following groups throughout the series:

Note: This series contains a logical overlap in the numbering order which affects numbers between 8507-8905 / 08507-08905. Previous to number 8507, customer numbers were four digit numbers. Beginning with 8507, it appears that the person stamping customer numbers began stamping a zero in front of some numbers (creating a five digit number). However, the four digit numbers also continued, creating different but numerically parallel customer numbers. Hence, number 8507 is a different portrait, sitting, and date than number 08507. Orders between 8507-8905 (and 08507-08905) are affected. After 8905/08905, the number stamping continues with only five digit numbers. The affected dates are between 2/28/1972 and 9/5/1974.

Series 2

General (12/10/1976-03/2011). Envelopes are arranged by customer number; index cards are arranged alphabetically by customer's last name and can be cross referenced to the envelopes through their numbers. The cards are physically separate from boxes containing envelopes. Includes 2.5 boxes of CDs.

Series 3

Schools (1978-1988). School portraits of students at SJO (St. Joseph, IL), Unity (Tolono, IL), ABL (Allerton-Broadlands-Longview, Broadlands, IL), JAM (Jamaica, Sidell, IL), and Uni (Urbana-Champaign, IL). Arranged by school, year, and then customer numbers. Cards are placed within each box.

Series 4

Kidz Club (c.1995-c.2005). Kidz Club was a program by McCandless to photograph infants at 3 months, 6 months, and 1 year of age. Arranged alphabetically by child's last name.

Series 5

Miscellaneous Projects and Notable Individuals. This series contains one time projects as well as envelopes selected by McCandless of notable individuals.

Sub Series 5.1

Notable Individuals (1966-1972). Envelopes and cards of notable people selected by McCandless after closing the studio. Included is a printed paper written by McCandless with the envelope number, name, and remarks about the subjects.

Sub Series 5.2

Champaign County Bar Association (1967). Approximately 250 envelopes of Champaign County Bar members. Arranged by customer number.

Sub Series 5.3

Urbana Police (1969). Approximately 31 envelopes of Urbana Police officers for a composite. Arranged by customer number.

Sub Series 5.4

First Christian Church (7/7/1972). McCandless photographed church members for a directory. Arranged by customer number.

Sub Series 5.5

Provena (11/1998-07/2003). A program with Provena to photograph infants at 3 months, 6 months, 1 year of age. Arranged by customer number.

Sub Series 5.5.1

Provena DNF (Did Not Finish [program]) (12/02/1998-7/24/2003). This subseries contains envelopes of those who did not complete the Provena program, separated from the Provena series by McCandless. Arranged by customer number.

Sub Series 5.6

Urbana Firemen (c.2007). Approximately 60 envelopes of Urbana Firemen. 3" x 2" color prints, no negatives. Arranged in no discernible order.
