The Kip Pope photograph collection was donated to the Champaign County Historical Archives in March 2020 by Kip Pope.

Access:

These records are accessible to the public within applicable copyright restrictions and limited to use at the Champaign County Historical Archives of The Urbana Free Library.

Historical Note:

A long-term business in the area, C and U Poster Advertising Co. was founded in 1912. Robert Pope, who worked for the company in the late 1930s, took over as president in the mid-1960s. He and his wife Barbara were the co-owners of the business until it was sold to relatives in 1984. From 1989 through 2001, the company was managed by their son Kip Pope. Afterwards, it was sold to Adams Outdoor Advertising Co.

During World War II, the company posted numerous advertisements to promote war bonds. In addition to commercial advertisements, C and U Poster donated billboard space for dozens of public service advertisements annually. The business was also the recipient of the American Chiropractic Association's National Community Service Award in both 1980 and 1981. This annual award was presented to outdoor advertising companies that contributed to public health education.

Scope and Content Note:

The collection mainly consists of photographs of local buildings, billboards, streets, and automotive artwork. Also included are images that are paired with correspondence and sets of photographs with a narrative.

Location information for some of the photographs has been added by the archivist. This information can be found in brackets on the reverse side of the photograph.

The automotive art subseries is currently unprocessed due to preservation concerns.710

Arrangement:

The collection is arranged into 3 series: Correspondence and Records, Photographs, and Slides.

Series 1: Correspondence and Records contains records, correspondence regarding images, and paper ephemera such as letterhead and newspaper articles.

Series 2: Photographs is further split into 5 subseries.

Subseries 1: Automotive Art consists of photographs of art and signage on automobiles.

Subseries 2: Billboards contain images of specific billboard advertisements or billboard infrastructure.

Subseries 3: Businesses and Buildings feature photographs where the main subject is either a specific business or a building.

Subseries 4: General Photographs consist of photographs that show an area of Champaign or Urbana. A few landscape photos are also included in this subseries.

Subseries 5: Streets and Addresses has photographs of specific streets, intersections, or addresses.

Series 3: Slides contains a variety of photographic slides. Most belong to a set, but there are also unidentified slides.
