Historical Note:

Alice Novak, former Assistant Head at the Department of Urban and Regional Planning at the University of Illinois Urbana-Champaign, worked in architectural preservation for over 30 years. A founding chairwoman of the Urbana Historic Preservation Committee, she helped to add many Urbana-Champaign buildings, such as the Orpheum Theatre, to the National Register.

In 2002, Novak purchased the DeWolf Residence at 601 W. Delaware Ave, Urbana. Built in 1933, it was designed in the French Revival architectural style by the local architectural firm Berger-Kelley and Associates for Frank Walbridge DeWolf and his wife, Fanny Davis DeWolf. The ownership has changed only five times since then, and the house has retained the majority of its original architectural features. Berger and Kelly, along with the DeWolf Residence, were featured in the August 1940 issue of Architecture & Design. Novak nominated the house for historical landmark status, and it was designated a historic landmark in 2016 by the City of Urbana.

Founded in 1923 by Fred E. Berger and Ralph L. Kelley, Berger-Kelley and Associates was a prominent architectural firm in Champaign-Urbana. Notable buildings they designed were Booker T. Washington Elementary School, the Co-Ed Theatre, Julia F. Burnham Hospital, and various other buildings in Champaign-Urbana. In 1954, sons Thomas E. Berger, Lynn Scott Kelley, and Kenneth E. Unteed took over management. The firm was renamed to Berger-Kelley-Unteed and Associates in 1958. It is unknown when they closed the business.
